I, Louise S. Lewis, County Auditor, Franklin County, Washington have examined the report of the last general election for the precincts of Connell, Mesa and Ringold and find that the following number of votes were cast at said election. Connell 296; Mesa 37; and Ringold 9; making a total of votes cast 342.

After checking the names of registered voters in said precincts I find 193 qualified electors who have signed a petition asking for the formation of Franklin County Public Hospital District Number One.

PETITION

FOR THE FORMATION OF FRANKLIN COUNTY PUBLIC
HOSPITAL DISTRICT NUMBER ONE

To the Honorable Board of County Commissioners, Franklin County,
Washington: Your Petitioners respectfully show:

I

That they are qualified electors of Franklin County, residing within the boundaries hereinafter set out; that your petitioners desire to organize and hereby propose the organization of a Public Hospital District to be known as Franklin County Hospital District Number One, for any and all purposes, and when established, the use of any powers that may be now or hereafter authorized and conferred by Chapter 264 of the Session laws of the State of Washington, as the same may be amended hereafter.

II

That the object of said district is to provide public hospital facilities within said district and generally to have all powers and

do all acts granted to Public Hospital Districts under the laws of the State of Washington, and the undersigned petitioners allege that the establishment of such district will be conducive to public safety, welfare and convenience and will be a benefit to the property herein described.

III

That your petitioners propose the formation of said district within the following boundaries:

Beginning at the Northwest corner of Franklin County, thence Southeasterly along the West boundary line of said County to the line between Township 10 North and Township 11, North, both in Range 28 E.W.M., extended to said boundary; thence East along said Range line extended East to the Southeast corner of Section 34 Township 11 Range 29; thence North to the Northeast corner of Section 22 Township 12 Range 29; thence East to the Southeast corner of Section 15 Township 12 Range 32; thence North to the Northeast corner of Section 3 township 12 Range 32; thence East to the Southeast corner of Section 34 Township 13 Range 32; Thence North along Section lines to the center of the right-of-way of O.W.R. & W. Co.; thence East along said right-of-way to the East line of Section 5 Township 13 Range 33; thence North along Section lines to the North boundary line of Franklin County; thence West along the North boundary line of Franklin County to the place of beginning.

IV

That your petitioners propose that Commissioner District Number One be established with the following boundary:

Beginning at the Northwest corner of Franklin County; thence Southerly along the West boundary line of said County to the line between Township 10 North and Township 11 North, both in Range 28

E.W.M. extended to said boundary; thence East along said Range line extended East to the Southeast corner of Section 34 Township 11 Range 29; thence North to the Northeast corner of Section 22 Township 12 Range 29; thence East to the Southeast corner of Section 15 Township 12 Range 32; thence North to the Northeast corner of Section 3 Township 12 Range 32; thence West to the Southeast corner of Section 34 Township 13 Range 31; thence North to the Northeast corner of Section 15 Township 13 Range 31; thence West to the Northeast corner of Section 17 Township 13 Range 30; thence North to the Northern Boundary line of Franklin County; thence West along said boundary line to the point of beginning.

V

That your petitioners propose that Commissioner District Number Two be established within the following boundary:
Beginning at the Northwest corner of Section 5 Township 14 Range 32; thence South on the Connell-Hatton Road to its junction with the State Highway No. 11; thence in a Westerly direction to Connell on "C" street; thence South on State Highway No. 11, to its intersection with the South boundary line of Section 36; thence West to the Southwest corner of Section 35 Township 13 Range 31; thence North on Section lines to the Southwest corner of Section 11 Township 13 Range 31; thence West on Section lines to the Southwest corner of Section 9 Township 13 Range 30; thence North on Section lines to the North boundary of Franklin County; thence East along said boundary to the point of beginning.

VI

That your petitioners propose that Commissioner District Number Three be established within the following boundary:
Beginning at the Northwest corner of Section 4 Township 13 Range 33; thence South to the center line of the right-of-way of the O.W.R. & N. Co.,

thence Westerly along said right-of-way to the West line of Section 2 Township 13 Range 32; thence South along Section lines to the Southwest corner of Section 35 Township 13 Range 32; thence West to the State Highway No. 11; thence North on said Highway through Connell to its junction with the Connell-Hatton road; thence North on the Connell-Hatton road to the Northwest corner of Section 5 Township 14 Range 32, which is the boundary line of Franklin County; thence East on said boundary line to the point of beginning.

VII

That your petitioners desire that the proposition of forming said hospital district be submitted to the voters residing within said district at the next general election.

WHEREFORE petitioners pray that your honorable body receive this Petition and fix a date for the hearing thereof and publish said Petition in the manner provided by law.
